Applicants must be US Citizens and Tecumseh City residents. Tecumseh Rotary Club and ReLeaf Michigan have matched and committed funds to a tree planting project for trees to be planted in Hotrum Park. The tree planting ceremony will take place on Saturday, September 15 from 8:45 to noon. On September 7 and September 14, Tecumseh STEAM students will work with Parks& Rec to improve the health of the forest at Indian Crossing Trails.

MOTION was offered by Council Member Riddle and supported by Council Member Harmon. A roll call vote was as follows:

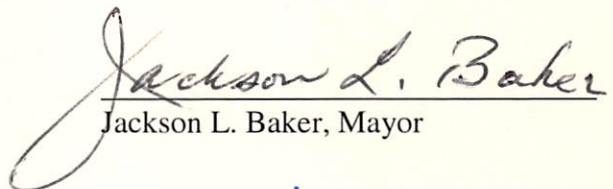
YES: Riddle, Wimple, Baker, Fox, Harmon, and Keiser.
