

**City of Tecumseh
Public Hearing Notice
Proposed Budget Resolution & Property Tax Millage Rate
Fiscal Year 2017-2018**

The property tax millage rate proposed to be levied to support the proposed budget will be a subject of this hearing.

At the regular meeting of the City Council of the City of Tecumseh, County of Lenawee, State of Michigan, that will be held on the 1st of May 2017 in Council Chambers at City Hall, 309 East Chicago Boulevard, Tecumseh, Michigan, at 7:35 p.m. the following resolution will be proposed:

Whereas, the Tecumseh City Charter provides that the Tecumseh City Council shall, by resolution, not later than the second Monday in May, adopt a budget of the City for the next fiscal year and shall provide for a levy of the amount necessary to be raised by taxes upon real and personal property for municipal operating purposes subject to the limitation contained in Section 9.1 of the said Charter, and

Whereas, a notice of the budget and the Public Hearing was published on April 20, 2017 and a Public Hearing was held on May 1st, 2017, at 7:35 p.m. in accordance with provisions of Section 8.3 of the Charter and Public Act No. 5 of the Public Acts of Michigan, 1982.

Whereas, the City Manager did prepare and submit to the Council a balanced budget for Fiscal Year ending June 30, 2018 in accordance with appropriate federal regulations, state law, and local Charter provisions;

Be It Resolved, that the appropriations for the Fiscal Year, commencing July 1, 2017 and ending June 30, 2018 are hereby authorized on a functional basis for the General Fund and as a Fund Basis for other funds, as follows:

Be It Further Resolved, that under Article 9 of the Charter of the City of Tecumseh, the Council does hereby determine that there shall be levied upon the real and personal property in the City of Tecumseh, a general ad valorem tax rate of **14.3966 mills** for General Operating purposes (Administration, Rubbish, Police, Emergency Services, Cemetery, Parks and Recreation, and other uses), for the Fiscal Year 2017-2018; and

Be It Further Resolved, that the total number of mills to be levied for the 2017-2018 fiscal year will be **14.3966** for general operations.
